DONATION REQUEST HANDLING POLICY
of the
INTELLECTUAL PROPERTY LAW SECTION
of the
IDAHO STATE BAR

The Intellectual Property Law Section often has funds available for making donations to other organizations, but those funds are limited. Each year, the Section receives a number of donation requests from other organizations. Following is the Section's policy for handling such donation requests.

Section 1 – FORM:

The Intellectual Property Law Section entertains only those donation requests that are submitted to the Section in writing. Requesters may utilize the Section's Donation Request Form for submitting their requests, but other forms of writing are acceptable. A sample of the Donation Request Form is contained within as Appendix A.

Written requests should be submitted to a current Section Officer. The Idaho State Bar makes available a list of the current Section Officers and their contact information.

Section 2 – TIMING:

The Intellectual Property Law Section of the Idaho State Bar considers donation requests once a year, at a time to be set by the Section's governing Council or Executive Committee. At such time, all outstanding donation requests will be considered by the members of the Section, provided the members present constitutes a quorum, as defined in Article IV, Section 3 of the Section's by-laws.

Section 3 – PURPOSE:

In considering donation requests, the Intellectual Property Law Section gives priority to requests that are related to the practice of Intellectual Property Law. Such practice includes the fields of domestic and international patents, trademark, and copyright property rights, unfair competition, and licensing issues.

Submission of a donation request for any purpose does not entitle the requester to a donation from the Section.

Section 4 – EXCEPTIONS:

Exceptions to the foregoing may be made at the discretion of the Section's governing Council or Executive Committee.
