Judicial Independence and Integrity in These Hyper-Partisan Times - Personal attacks on judges undermine the fundamental principles of justice. This distinguished panel will discuss the importance of the independence of judges in resisting political pressure and reinforcing the fair and impartial administration of justice. Join this critical conversation that goes to the heart of a constitutional democracy and the role of every lawyer in defending the integrity and independence of the rule of law. The Basics of Indian Law for General Practitioners in Idaho - Topics will include the interrelationship between state, federal, and tribal civil and criminal jurisdiction, an overview of Indian Country, the tribal trust doctrine, forms of tribal land ownership, issues related to checkerboarded reservations and land fractionation, the sale and purchase of tribal lands, and tribal sovereign immunity related to conducting business in Indian Country with Indian tribes and tribal enterprises. The Task Force is soliciting information about practitioners' experience in Idaho's civil justice system. The Task Force will use the data gathered to determine what, if any, changes should be recommended to the Idaho Supreme Court. Idaho Rule of Professional Conduct 1.1 unwaveringly requires lawyers become and remain competent as this tidal wave of new technology surges forward. Ethics and Practical Issues in Dealing with Persons with a Developmental Disability - This CLE will provide answers to an array of questions. Does an individual proposed to be under a guardianship have a right to his/her own attorney? Does an individual under a guardianship have the right to contract with an attorney to contest or change the terms of the guardianship after *Rogers*, considering IC 15-5-307(a) and IC 66-408? What are the implications of IRPC 1.14, Clients with Diminished Capacity, for the attorney or GAL who represents an individual in a guardianship? Under what circumstances should a guardianship be plenary in light of the *Rogers* case, IC 66-406 and IC 15-5 part 3? When does supported decision making need to be considered? What are the changes to ICAR 54.4 and 54.5? What are the implications of SB 1090 that clarifies that an individual with a developmental disability who does not have a guardianship and has capacity to make decisions is allowed to make decisions? *Robert L. **Idaho and a Constitutional Convention** - The United States Constitution has been amended 27 times. In each instance, Congress proposed amendments for ratification by the states. In the past two decades, the Idaho Legislature has been pressured to amend the Constitution using an alternative method. Article V expressly provides for a state-called constitutional convention in which delegates from at least two-thirds of the states meet to propose amendments to the Constitution for later ratification by three-fourths of the states. While efforts to call an Article V convention are not new, such efforts are intensifying and an Article V convention is increasingly more likely. This presentation will outline the legal basis for an Article V convention, identify legal uncertainties inherent therein, and provide commentary on the potential benefits and detriments of an Article V convention. *McKay Cunningham, Concordia University School of Law; Latonia Haney Keith, Concordia University School of Law* 

**The Trend Toward Proportionality in Discovery** - The proportionality requirements for discovery under the federal rules went into effect in December 2015. Some state courts, including Idaho's, have also moved toward adopting proportionality limitations for discovery. This program will look at the policy reasons behind the proportionality requirements and whether those requirements are impacting how litigators manage their cases and conduct discovery.
