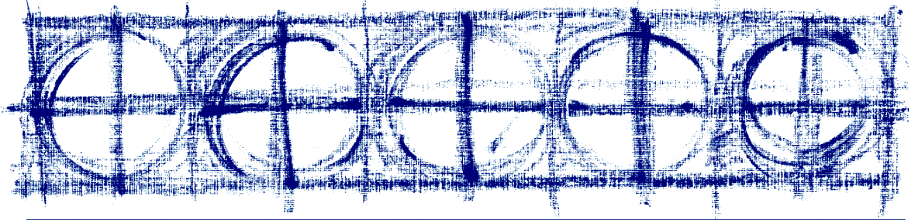

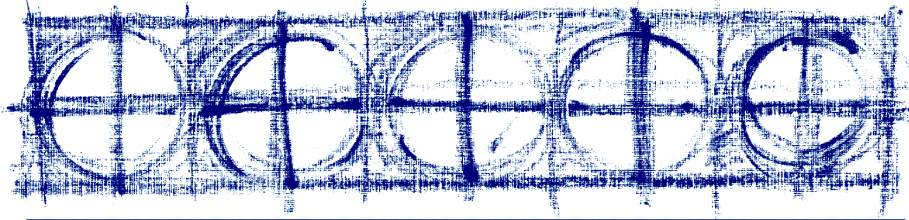

Please join the Idaho Volunteer Lawyers Program (IVLP) in saying a special thanks to the **630** Idaho attorneys who accepted or completed pro bono assignments in family law, immigration, consumer protection, wills, benefits, foreclosure matters, and other needs for IVLP applicants in 2017. The work accomplished by volunteer attorneys impacted over 2,900 people and by donating **approximately 6,540 pro bono hours** in legal services is valued at over one million dollars in donated time. Some of the volunteers helped represent individuals in domestic violence civil protection order hearings, stepped in to represent Court Appointed Special Advocates in child protection cases, assisted grandparents by establishing guardianship for a grandchild, or helped a refugee senior in their Naturalization process. The ***IVLP Wall of Fame*** also includes the names of attorneys or judges who participated in other IVLP activities including: Legal Clinics held for Veterans, Seniors and the larger community, or on the Bankruptcy Helpline. Volunteers presented informational sessions on family law to groups of parents at various public venues and to incarcerated mothers through IVLP's *Soundstart* program. Attorney members of the Idaho Pro Bono Commission and the IVLP Policy Council are also listed.
