FEE INFORMATION

- **Team Registration:** Each registration form must include a *nonrefundable* fee of \$150.00 per team (\$200.00 per team after December 15, 2015). **No teams may register after January 29, 2016.**
- **Season Completion Deposit:** In prior years teams have dropped out of the competition at the last minute, resulting in increased expenditures for the program. Therefore, we require a \$50.00 deposit per team. This deposit will be refunded to each team that participates in the competition. Teams that cancel after January 31, 2016 agree to forfeit their deposit to cover the expenses associated with their cancellation.
- **Case Materials:** To save on copying/mailling costs, we will send case materials via email. If you prefer to receive a hard copy of the materials, add \$25.00 (per copy). A copy includes materials and a binder.
- **Courtroom Artist Fee:** Each participating school may enter up to one artist per team. The fee is \$25.00 per artist. For more information, see the *Courtroom Artist Information Sheet* on the Idaho Law Foundation website.
- **Reduced or Waived Fees:** If your team is having difficulty in paying the registration fee, contact Carey Shoufler to discuss the possibility of reducing or waiving mock trial fees.
