Every August, the Professionalism & Ethics Section of the Idaho State Bar, in partnership with the University of Idaho College of Law and Concordia University School of Law, provides an *Orientation on Professionalism* for incoming first year law students. The program emphasizes the importance of ethics and professionalism at the very outset of a legal education.
