- 3) The Annual Bar Conference will be held July 13-15 in Sun Valley, Idaho. In addition to holding a Section meeting, the Section will sponsor a 1.5 hour CLE on perspectives of in-house and outside counsel on real estate transactional work.

New Business:

- The Diversity Section's chairperson, Dina Flores-Brewer, gave a report on current plans for a Bill of Rights Symposium scheduled for September 14-16, 2011, with activities planned for Moscow and Boise. Plans include the pairing of high school students with attorney mentors during the Symposium. Upon motion duly made and seconded, the Section approved a \$5,001 donation to the Symposium. Further details about the Symposium will be circulated by the Bar.
- 2) The Section has submitted an application to the Bar for the Section of the Year Award.
- 3) The Funding Requests Committee will continue to meet on a quarterly basis to consider requests made to the Section for funding.

MONTHLY CLE:

Randal J. French of Bauer French presented the monthly CLE on the topic "A Brief Look at Bankruptcy, Real Estate and Section 364 of the Code."
