			<p>has the highest rate of incarceration of any nation in the world, and the nationwide cost to state and federal budgets was \$80 billion in 2010 alone. These efforts include partnerships with all of the stakeholders in the federal criminal justice system: the courts, probation, and the federal defender. Panelists will discuss their experience with specialty and re-entry courts in Idaho and Utah.</p>
