Presenters

Travis Marker, the founder and director of the Scrivener's Quill: A Center for Lawyers and Literature, graduated from Weber State University with a double major in English and History from Weber State University. Reading books helped him survive law school. He received his law degree and certificate in dispute resolution from Willamette University College of law. Mr. Marker traveled to Australia where he received a Master of Laws in dispute resolution from Bond University. Mr. Marker is the most active scholar presenting CLE on literature's application to the practice of law. He has presented to hundreds of attorneys throughout the United States on the subject.

Mr. Marker is also a pro-tem judge, attorney, mediator, and social entrepreneur. His primary genre in the practice of law is "domestic." He provides services to nearly every area of law that affects families including divorce, custody, adoptions, grandparent rights, termination of parental rights, child welfare and juvenile delinquency, couple mediations, family conflict resolution, child support, parent time and visitation conflicts, and other families matters.

Kristie Browning, MPA is a Certified Professional Mediator. She began mediating in 1992 and by the end of 2017 had mediated over 3,300 cases. Prior to that Kristie worked in the private communications industry in two different companies as Comptroller, General Manager and General Partner.
