Entry fee is \$60.00 per person (includes lunch) with golf cart, or \$45.00 per person (includes lunch) without a cart.

Our greens fees have to be reserved and paid for in advance. Your entry form and payment must be received by Monday, September 16. The order of teams at the shotgun start will be semi-arbitrary, trying to have different geographic teams playing in order; i.e., if one firm sends two teams we will try and set it up so they are not playing directly in front/behind each other, that way folks can meet and greet better. Prizes will be awarded at the conclusion of the tournament. All scoring will be gross.

To earn 2.0 Ethics CLEs, there will be a question from the MPRE at each tee on the front nine, answers on the green - read the question, tee off, talk about it, putt, and get the answer.

SCRAMBLE RULES

1. The tournament is run on a team scramble format. First and second places for teams are determined by the lowest gross scores. In the event of a tie, a chip-off will be held, with the rules to be determined by the tournament directors. To determine third place, a chip-off will be held among the three other teams with the lowest scores.
2. On each tee box, each player hits a first drive, one of which is chosen to be the team's first shot. All four players hit the next shot from within one foot of that lie, no closer to the hole. If the lie is within a hazard, all shots must be made from within the hazard. Putts must be made from within six inches of the preceding shot or putt.
3. The drives of every player must be used at least once each on the front and back nine, including par 3 holes.
4. As a consideration to all participants, attempt to finish the round in 4 hours. If a ball is lost, allot a maximum of two minutes to look for it. Fill any divots with sand or replace them, and repair all ball marks on the green.
5. IMPORTANT Closest to the pin contest for the women is on green# 2. Closest to the pin for the men is on the other par 3 holes: # 6, 11, and 15. Longest drive contest for the men is on # 9, longest for the women is on # 18.
