Thursday, July 21 - CLE Session 1 - 9:00 - 10:45am

Millennials Rising: This Ain't Your Parents Legal Profession - Shoshone Falls - The legal industry is undergoing seismic change. Millennials are moving into law firm, corporate in-house, and public-sector leadership positions against the backdrop of a landscape that has been fundamentally redefined by COVID, a shifting regulatory framework, and intense new competitive pressures. Fueled by one of the tightest labor markets in decades, the "Great Resignation" of the last two years has tested the historically slow-moving legal industry's ability to adapt and make the changes needed to attract and retain talent. What motivates the next generation of lawyers? What are the best firms and legal employers doing right and wrong? How can you position your firm, practice, or organization for success? (1.5 CLE Credits)

Discrimination Based on Gender: Reconciling Bostock in a Rapidly Evolving Workplace - Perrine Falls - In this CLE program, current practitioners will discuss legal protections for transgender employees under Idaho and federal, current litigation around bathroom use and other transgender issues, and best practices for employers with transgender employees. Expert Disclosures: The Good, The Bad and The Ugly - Auger Falls/Twin Falls - A civil practitioner's detailed guide to withstanding a motion to exclude experts in state court. The presentation will specifically address the issues that might preclude expert testimony based on the court's scheduling order, timing of the disclosure, the qualifications of the expert and the specific requirements of I.R.C.P. 26(b)(4)(A), as well as the role of supplementation. The presentation will also address when the opportune times are to file a motion to exclude opposing counsel's experts. (1.0 CLE Credits - NAC)

From Alston to NIL to Future Employment? Recent Legal Developments in College Athletics Governance - Auger Falls/Twin Falls - This presentation will provide an overview of developments in the law surrounding the governance in college sports, specifically as it relates to the current standing of the NCAA's amateurism requirements following the Supreme Court's 2021 decision in NCAA n Alston. Along these lines, this presentation will cover the Alston case and its aftereffects, including the NCAA's rule changes allowing athletes to profit off of their names, images, and likenesses and pushes for courts and/or the National Labor Relations Board to find college athletes to be employees of their schools and/or the NCAA under federal wage, hour, and labor law. Promoting Diversity, Equity, Inclusion, and Belonging in Your Organization - Perrine Falls - In light of the ISB membership's vote to adopt proposed IRPC 8.4(g), this session will include a discussion on common challenges to promoting a diverse and inclusive environment in the legal profession, and best practices to overcoming those challenges in individual workplaces, the courtroom, and beyond. The session will include an interactive workshop component in which presenters will have participants work through common hypotheticals of challenging workplace and courtroom scenarios.
