# Commercial Law & Bankruptcy Section Meeting Minutes

# May 17, 2023 Meeting

Meeting started at: 4:10 pm

- 1. <u>Call to Order</u> Brian started the meeting at approximately 4:10pm
- 2. Judge Hillen Pro bono opportunities

Judge Hillen discussed increasing pro bono opportunities for bankruptcy attorneys. Judge's wondering how to encourage pro bono BK work, and whether the Court can do things to make it easier. Judges have ideas, maybe create some sort of cooperative system. Maybe volunteers to be on roster from pro bono work for pro se cases – court could reach out when a case happens. Is this something attorneys are interested in doing? What is the scope of cases that attorneys are willing to cover? In past, some push-back from consumer debtor bar who sees it as competition. Maybe adversary proceedings – nondischargeability or student loan cases?

Brian comments – definitely a practice area where pro bono work could be helpful. Maybe have a discussion on the listserv. Board to discuss further, including discussion of continuing conversation with Judge Hillen & Meier.

Further discussion by the board on the topic. Patrick assigned to discuss issue further with Judge Hillen and report via email.
