Dear Litigation Section of the Bar,

My name is Brady Dunn and I'm a senior at Timberline High School and a member of its varsity debate team. I, along with 6 of my teammates, recently qualified for the National Speech and Debate Association's national competition being held in Phoenix, Arizona in mid June. But, as it stands, we will be unable to attend the competition and represent our school district due to a lack of funding and general support from our school's administration. We are currently \$7,000 short of attending the competition and were wondering if the Litigation Section of the Bar would be willing to financially contribute to our journey to nationals?


For many of our team's qualifiers, including myself, this will be the last time we will ever be able to compete in high school speech and debate making it a momentous and deeply profound experience for us. As we see it, debate education is a crucial aspect of both law and justice and can better prepare the next generation of paralegals, attorneys, and judges to fulfill their role in upholding the integrity of the American legal system. Over the course of this year for example, we have debated the moral and legal merit to our nation's current immigration laws, the effectiveness of Idaho's right to work laws, digital user protections, and many other relevant political and social dilemmas. And it has been this practice over the past three years that has inspired me to enter into higher education with the goals of one day becoming a lawyer, a story that rings true for countless other speech and debate participants.
