Services	Description	Cost
Parenting Plan Assistance	Parties may receive individual assistance with parenting plans.	\$50 per 2-hour session
Child Custody Mediation	A form of Alternative Dispute Resolution that aims to assist parents in reaching an agreement. If the parties reach agreement, they have determined the outcome rather than accepting something imposed by a third party. Mediators use techniques and skills to open and/or improve dialogue between parents, aiming to help the parties reach an agreement on the disputed matter.	\$180 per session (2 hours), split between parties
Idaho Family Civil Intake Screening (FCIS) I.R.F.L.P. 601	A case screening that provides the Court and parties with options for efficient case management while identifying the most effective service that may assist parents in resolving their case. Assesses concerns related to domestic violence, substance abuse, and mental health, and any other factor that might indicate level of conflict.	\$125 per case
Two Homes, One Family Co-Parent Communications Consulting I.R.F.L.P. 1001	<i>Two Homes, One Family</i> offers parents an opportunity to improve on their communication. Sessions are composed of education, discussion, and problem-solving toward co-parenting matters. Parents will each have opportunity to engage in individual check-in between group sessions. Through the program, Consultants work to aid parents in creating a communications contract. Joint sessions are held twice per month; Joint sessions are approximately 6-8 sessions; Special court order required	\$500 per party, includes all sessions and materials.
Parenting Time Evaluation I.R.F.L.P. 1004 (Sometimes referred to as Custody Evaluation)	An in-depth evaluation of the individual and family dynamics that affect the <u>best interests</u> of children (I.C. 32-717) and provides parenting time recommendations. Includes individual interview with the parties, interview of collateral contacts, child interview, parent-child observation, review of records, home visits and more	\$5,000 per case, \$2,500 per party, includes written report

Brief Focused Assessment I.R.F.L.P. 1005	An assessment that responds to a circumscribed legal question that is narrowly defined and requires judicial action. Limited to three issues only. A Brief Focused Assessment may also be used to expedite an answer to a specific area to allow the court to proceed with decision making without further assessment.	\$1,600 per case, plus \$200 per additional issue, up to \$2,000 per case
Child Interview Appointed as Court's Expert, I.R.E. 702	Interview of children age 9 and older. Interview and report aid the Court and parties in deciding factors related to wishes of the child(ren). Special court order required.	\$300 per case, plus \$50 per child after the first.
Therapeutic Supervised Access I.R.F.L.P. 1003	Conducted by a trained, qualified professional to reduce risk to children during visits and exchanges. Visits and exchanges are monitored and occur at a neutral location; short-term, may include a recommendation for supervised visitation following therapeutic intervention. Special court order required.	\$165 per hour, \$82.50 per party
Reintegration Therapy I.R.F.L.P. 1001	Conducted by licensed, trained professional. Goal is to reintegrate a parent back into a child's life in a controlled and therapeutic manner to establish a new and secure bond.; long-term. Special court order required.	\$165 per hour, \$82.50 per party
Parenting Coordination I.R.F.L.P. 1002	For high conflict parents who often return to court to settle disputes, sometimes known as "frequent flyers." The Parenting Coordinator makes decisions (within the confines of the court order) for the parents when they are unable to agree.	\$500 retainer, \$150 per hour, \$75 per parent
Interdisciplinary Settlement Conference	An opportunity for parties to meet and attempt to resolve any outstanding legal issues pertaining to their case. Generally, parties meet with counsel, if represented, a mental health professional and a professional with a legal and mediation background. A judicial magistrate, either presiding over the case or another, may help officiate the settlement conference.	\$600 per party
