Training Information:

The department and Administrative Office of the Courts (AOC) have partnered to develop Pathways to Permanency, permanency-themed trainings and local collaboration meetings to be held in each region this fall.

The training will include information about the timeliness of court hearings, differences between adoption and guardianship including available supports, and the department's use of early reunification and poor prognosis indicators to help identify the most appropriate permanency plan for each child and family. Each convening is 1 ½ days to include 1 day of training and a ½ day of local collaboration where child welfare community partners with come together with local child welfare judges and department staff to talk about ways to implement what was learned in the local area.
