Title: Typography for Lawyers: Tips and Tricks to Enhance Professionalism in Messaging

General overview of presentation:

- What is Typography? The visual component of the written word. Includes: font, spacing, and formatting
- Why Important? subconscious impact; lawyers are expected to be the masters of the written word, which includes formatting; professional and polish for external and court documents – creates a stronger message and greater efficiency
- Ethical Implications Rule 1.1. Competence and Rule 1.3. Diligence
 - Polished documents convey competence, show effort to zealously advocate, and promote better communication
- Things to consider:
 - o Line breaks
 - Do not leave header titles at the end of the page
 - Turn on formatting marks and use styles/keyboard shortcuts rather than use of multiple tabs, paragraph breaks, etc.
 - Nonbreaking Spaces to keep dates, times, reporters, section symbols, etc. together at the end of a line
 - o Double Spacing
 - Single space after periods
 - Unnecessary with modern fonts
 - Visual Elements
 - People read left to right, top to bottom
 - If pictures are on the left side, eyes go to that instead of the text on the right side. Keep photos on the right side
