Guidelines for Requests to Contribute Funds

Sections of the Idaho State Bar, or other organizations, requesting financial participation from the Business and Corporate Law Section of the Idaho State Bar should submit the attached application to the Section Chair for consideration by the Governing Council. Requests for funds from the Business and Corporate Law Section should state how the request relates to or furthers the goals of the Business and Corporate Law Section, which are stated in the Section's Mission Statement:

The mission of the Idaho State Bar Business and Corporate Law Section is to foster ethical behavior in the practice of business and corporate law; provide leadership in the development of business and corporate law; and enhance the professional growth of the Section's members.

Grants of Section funds will usually be limited to \$2,000.00. The Governing Council may consider support in excess of this amount, depending upon the degree to which the project meets the mission and goals of the Section, the distinction and need of the project, and the availability of funds.

The Business and Corporate Section will receive applications annually on or before October 1 for funding in the coming calendar year. The Governing Council or an appointed committee will review each application and make recommendations for a final decision by the Section's Governing Council not later than the Section's regularly scheduled December meeting. To the extent the Section's budget allows and applications are made after the October 1 annual deadline, the Section, at its discretion, may consider additional applications submitted on or before March 1 for consideration at the Section's May meeting.
