#### 1. A lawyer is:


- (a) a member of the legal profession;
- (b) a representative of clients;
- (c) an officer of the legal system;
- (d) a public citizen having special responsibility for the quality of justice.



2. Representing clients in various ways:

- advisor
- advocate
- negotiator
- evaluator

#### 3. Other roles of lawyers

➤ A lawyer remains a lawyer even while engaging in other roles, as a neutral, an inactive practitioner, or acting in a non-professional capacity.



#### 4. Professional qualities

A lawyer should always be competent, prompt, diligent, communicative with clients, and keep clients' communications confidential.

#### 5. Conduct standards for lawyers:

- ▶ (a) should conform to legal requirements in practice, business and personal matters;
- ▶ (b) a lawyer should not harass or intimidate others in using the law's procedures;
- (c) show respect for legal system, including judges, public officials, other lawyers;
- ▶ (d) uphold the legal process even as the lawyer challenges official rulings and actions.

## 6. A lawyer's public citizen responsibilities:

- (a) improve the law and access to justice;
- ▶ (b) improve the administration of the legal system;
- (c) assist law reform efforts; (d) strengthen legal education;
- (e) strengthen the public's confidence in the rule of law and the justice system;
- (f) address unequal access to justice;
- (g) aid the Bar in regulating itself in the public interest.

## 7. Sources of professional conduct standards:

- ▶ IRPC; substantive and procedural law.
- ► A lawyer is also guided by personal conscience and the approbation of professional peers.
- A lawyer should strive to attain the highest legal skill level
- ▶ Strive to improve the law and legal profession
- Exemplify ideals of public service



# 8. A lawyer's responsibilities to clients, as legal system officer, and as public citizen.

- A lawyer's responsibilities in representing clients, as an officer of the legal system, and as a public citizen, are usually harmonious.
- Zealous advocacy on both sides ensures justice.
- Clients' knowledge that communications are confidential serves the broader public interest.



### 9. Conflicting responsibilities can be encountered:

- (a) IRPC often prescribe terms for resolving conflicts;
- ▶ (b) a lawyer must also use sensitive professional and moral judgment;
- (c) guided by the IRPC's underlying principles, to protect the client's legitimate interest, to preserve the integrity of the legal system's search for truth, while maintaining a professional, courteous and civil attitude towards all persons involved in the process.



# 10. Legal Profession is largely self-regulating.


- ➤ The legal profession is unique because of close relationship between the profession and government, including law enforcement.
- Ultimate authority over legal profession is vested in the courts.

# 11. Self-regulation assists in maintaining the legal profession's independence from government.

- Independent legal profession is an important force in preserving government under law.
- Abuse of legal authority can be challenged by lawyers.



# 12. Special responsibilities of self-regulation:

- (a) not furthering parochial interests of the Bar;
- ▶ (b) lawyers should adhere to the IRPC and ensure that adherence by other lawyers.

# 13. Lawyers play a vital role in the preservation of society.

- Lawyers should have an understanding of their relationship to the legal system.
- The Idaho Rules of Professional Conduct serve to define the relationship of lawyers to the legal system.
