# Introduction:

The Child Welfare Advisory Board of Idaho is a pivotal platform that brings together key stakeholders, including Child Welfare Staff, community partners, and child welfare advocates, to collaboratively enhance the state's child welfare system. The Child Welfare Advisory Board represents a cross-section of expertise and experience within the child welfare landscape. Members include Child Welfare Staff, community partners such as law enforcement, courts, service providers, foster parents, and other child welfare stakeholders. Membership is determined through appointment by the director of the Idaho Department of Health and Welfare, reflecting a commitment to inclusivity and collaboration.

The Child Welfare Advisory Board is dedicated to regular and meaningful engagement. To ensure consistent collaboration and progress, the board will convene on a quarterly basis. These quarterly

meetings will provide a forum for members to discuss priority improvement areas, review Situation Group analyses and reports, and collectively recommend focus and direction for enhancing the child welfare system in Idaho. The regularity of these meetings underscores the board's commitment to driving sustained improvement and ensuring that the voices of all stakeholders are heard in shaping the future of child welfare in the state.

#### Function and Collaboration:

The board collaborates closely with the Child Welfare Steering Committee, a leadership body comprising the Family and Community Services Administrator, deputy administrator, and Family and Community Services Bureau Chiefs. The board recommends priority improvement areas to the steering committee, which then plays a decisive role in finalizing these priorities.

To ensure comprehensive analysis and actionable insights, the board forms Situation Groups. These groups consist of experts possessing deep knowledge of specific focus areas. Situation Groups conduct detailed analyses and generate reports on the current state within each priority improvement area. These reports serve as the foundation for the board and steering committee's decision-making process.

#### Leveraging Knowledge and Progress:

The insights and analyses generated by Situation Groups form the cornerstone of the board's efforts to monitor improvement progress. Additionally, these analyses guide the activities of A3 improvement teams responsible for implementing strategic interventions.
