- I. Call to Order
 - a. Roll Call, Members & Guests Present:

- II. Approval of Past Meeting Minutes (July 27, 2018)
 - a. Because meeting did not have Quorum, no votes on action items could be held. As a result, approval of past meeting minutes was not done. Will table for next meeting.

 - a. Treasurer Jim Cook was absent from the meeting. As a result, no Treasurer's report was given. Brit estimated that our current balance is around \$8,000.00 from review of most recent financials, indicating significant revenue from the annual conference CLE.

 - a. Courtney reported that in the Treasure Valley, Committee is working on organizing an event with Judge Onanubosi at the Canyon County Courthouse on December 11, 2018.
 - b. Courtney reported that LTL member Kinzo Mihara, in Northern Idaho, is working on organizing an event with the Federal Courthouse in Coeur d'Alene for November 6, 2018.
- V. Future CLE December 6, 2018, from 2-5PM on Language Access Issues in the Courts
 - a. Group discussed potential agenda as follows:

 - Andrew will provide a general overview of what an interpreter does, the interplay between the requirements to provide interpreters set forth in state court rules and federal laws such as the ADA, and the various equipment or resources that are now available in courts statewide (i.e. VRI) (with approximately 10 minutes allotted for Q&A).

 - a. Brit is continuing to work on this with Animal Section duplicative membership. New members may roll in after attorneys are sworn in next month.
