#### I. Call to Order, Introductions

### III. ACE Annual Report and 2018 Budget Request

Rebekah Cude, ACE co-chair, presented an update on ACE's activities, beginning with an overview of the groups or activities that ACE supports (We the People, Idaho Law Foundation Mock Trial Program, and the YMCA Youth in Government Program). ACE was awarded a community grant from the U.S. District and Bankruptcy Courts for the District of Idaho, to be used for a journalist institute. ACE's other notable accomplishments included:

- Organizing the "I (Heart) Civics" CLE in February 2017, which ACE co-hosted with the University of Idaho at the ILJLC
- The Hilarity for Charity event, which continues to be a success
- Editing and updating the "Turning 18 in Idaho" brochure
- Deploying members, colleagues and friends to Law Day, Constitution Day, and the We the People state and national competitions
- Presenting at Renaissance High School and Cole Valley Christian School

On behalf of ACE, Ms. Cude requested a renewal of the \$2,000 in financial support that the GPSL section provided last year. This amount includes:

- \$150 for website-related expenses (bi-annual domain fee, web architect, etc.)
- \$200 for marketing expenses for events, including sponsor recognition materials
- \$1650 for operating expenses for the Hilarity for Charity event.

There was also discussion regarding linking the Section's website to ACE.

ACE's next meeting will be December 21, 2017 at the ILJLC, in the third floor conference room.

Bryan Norton moved to provide \$2,000 in financial support for ACE in the next year. Adam Dingeldein seconded. Motion carried.
