

U.S. DISTRICT COURT EVENT (BOISE) EVENT SUMMARY

Event Title: U.S. District Court Event (Boise)

Date & Time: April 9, 2019, 8:30AM-1:30PM

Location: U.S. Federal District Courthouse, 550 W. Front Street, Boise, Idaho.

Number of Students: 30 students and chaperones.

Participating Schools: Kuna High School; Middleton High School; Marian Pritchett High School (Boise); Boise High School; and 1 BSU CAMP/HEP Student

Summary of Events: For its Federal Courthouse event in Boise, Love the Law! invited students to the Federal District Courthouse in Boise to observe two criminal sentencing hearings and hear from a panel of employees within the Federal court system. The event began with a welcome and introduction to the Love the Law! program by Chair, Courtney Holthus, followed by an overview of what to expect in the Courtroom and a preview of the sentencing hearing by Amy Tate, Courtroom Deputy to the Honorable Candy W. Dale. Students were then escorted to observe two sentencing hearings before Judge Lodge: *USA. v. Fausto Mascorro*, 1:18-cr-0095-EJL and *USA v. Miguel Luna*, 1:18-cr-00351-EJL. Afterwards, students were able to ask Judge Candy Dale questions about the sentencing hearings and courtroom observations. While lunch was served, students then participated in a panel discussion with Judge Candy W. Dale, U.S. Magistrate Judge; Rafael Gonzalez, First Assistant U.S. Attorney; Mandy Arnold, Supervisory U.S. Probation Officer; Paul Baxley, Deputy Chief U.S. Marshal; and Nicole Owens, Federal Public Defender. Panel members shared information regarding their background and respective career paths, answering questions, and discussed the various challenges they face in their respective positions within the Federal Court system. Students and chaperones then departed at approximately 1:30 PM.

Amy Tate provided a massive amount of assistance with this event, from helping to coordinate dates and panel speakers to volunteering to provide an overview presentation to the attendees all the way to actually helping to coordinate room set up and clean-up afterwards. What they liked best about the event:

What they liked least about the event:

- Not as much interaction.
- Not being able to hear presenters.
- The intro was a little slow going.
- Nothing, it was great.
- The lunch forum's topic and panelists were relevant, but I'd suggest using a microphone next time as it was very difficult to hear in the back of the room.

How we can improve the event:

- Getting a chance after the hearing to ask questions to the Judge about his verdict.
- More interaction that the students can have with each other.
- Make the first 30 minutes more interactive and engaging.
- Decrease wait time.
- I wish we could have seen a trial, but understand that may not be possible.
- Give more information on opportunities for other students to get internships, pathways to being judges, etc.
- More cases, different types of cases.
- Maybe more variety in the subject matter of the cases, if that's even possible to control.
- Need microphone for panel lots of fan noise.
- More organized panels.
- Maybe give a lesson on key terms that are commonly used in the courts, because it can be hard to understand.

Ideas for other LTL! events:

- Criminal court cases.
- Maybe incorporate some workshops with each panelist.
- Jury trial observation.

- A legislative tour/panel.
- The variety of careers for lawyers as well as court careers including pre-law school education, paying for law school, and other education to work at a courthouse.
