About NACC

NACC advances the rights, well-being and opportunities of children impacted by the child welfare system through access to high-quality legal representation. We provide training and resources to practitioners, advocate for policies that advance children's rights, and support a community of hard-working and dedicated child welfare/juvenile attorneys.

Role & Responsibilities

State Coordinators help lead outreach efforts and provide localized support to growing networks of practitioners in their respective states. Their role is a key component of NACC's [strategic plan](#) and community building strategy. Responsibilities include:

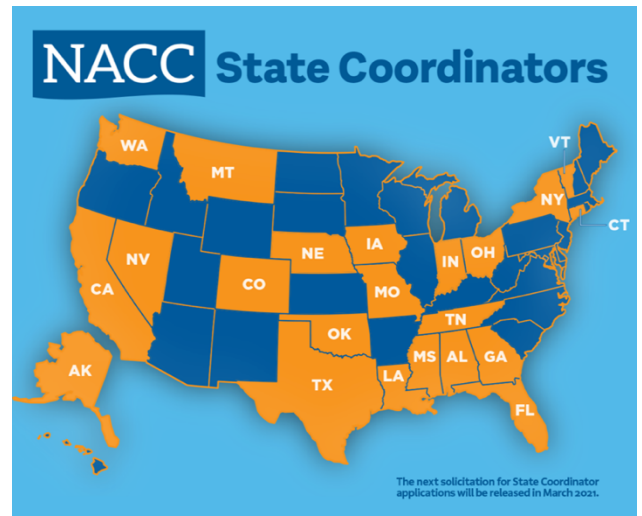
- Serve as a liaison between NACC and child welfare practitioners, courts, organizations, and law schools;
- Help grow the community of NACC members and Child Welfare Law Specialists, including sending quarterly emails to legal professionals and supporting state listservs;
- Submit quarterly updates describing state practice concerns and policy developments;
- Participate in quarterly calls with other State Coordinators and NACC staff;
- Plan at least one annual event, such as attorney trainings, webinar viewings and discussion, or town halls (events can be held online); and
- Attend NACC's National Conference (onsite or online).

Time Commitment:

- Approximately 5 hours per month;
- Two-year time commitment (2021-2023 cycle).

Compensation:

- \$500 annual stipend;
- NACC membership at the Gold level (includes a hard cover Red Book);
- NACC National Child Welfare Conference registration;
- Red Book Training Course registration; and
- Coaching, resources, and materials to support this role.



Selection Process:

- The deadline to apply is **April 5, 2021**.
- NACC currently has established State Coordinators in over 20 states. In this application period, we are seeking to expand to at least 10 new states/ jurisdictions. Candidates from the following locations are especially encouraged to apply: AK, AZ, AR, DE, DC, HI, ID, IL, KS, KY, ME, MD, MA, MI, MN, MS, NE, NH, NJ, NM, NC, ND, OK, OR, PA, PR, RI, SC, SD, UT, UVI, VA, WV, WI, WY.
- State Coordinators will be selected based upon individual experience, skills and qualifications, as well as state-related factors (ex. policy needs, NACC membership levels, etc.)

State Coordinator Attributes & Qualifications

- 5+ years' experience as a dependency attorney (representing children, parents, agencies, kin or tribes), judicial officer, or policy advocate with practice experience;
- Passionate about the development of high-quality legal representation, especially children's right to counsel;
- Commitment to race equity, diversity and inclusion in the practice of child welfare law;
- Dedication to elevating the voices of youth and parents with lived experience;
- Active and engaged within state child welfare community with experience building positive relationships with stakeholders;
- History of engagement with NACC (current or prior member, conference attendee, etc.);
- Preference for Child Welfare Law Specialists (CWLS).

- Why are you interested in serving as an NACC State Coordinator?
- How are you currently engaged with practitioners in your state, including any potential relationships with legal services providers, courts, law schools, bar associations, and other relevant entities?
- What is your experience organizing people and projects?
- Does your office or agency support your potential role and activities as a State Coordinator?
- How would an NACC State Coordinator benefit child welfare law, practice and policy in your state?
