# TAXATION, PROBATE, AND TRUST SECTION Meeting Minutes for June 12, 2018

### 1. Call to order/attendance

Section Chair Robert J. Green called the meeting to order.

## 2. Approval of prior meeting minutes

A motion was made and seconded for the approval of the April 6, 2018 meeting minutes, which were unanimously approved.
